She won a National Legislative Achievement Award from the National Association of Health Underwriters (NAHU) for her work in Legislative Communications to employers and the industry, and her work in HIPAA education in 2001. Dorothy began her administrative experience in the Taft-Hartley marketplace in 1984, then moved to self funded administration after three years. Dorothy left the TPA field in 1995 to develop Advanced Benefit Consulting, a benefits and third party administration consulting firm specializing in self funded health plans and their administration. Her clients include fully insured and self-insured employers, third party administrators, excess loss carriers, general agencies, health care providers and the U.S. Department of Labor. Ms. Cociu has had over 90 articles published on topics such as HIPAA Privacy, ERISA, Self Insurance, COBRA, Federal and State Health Care Reform, and Managed Care Reform. She has also been interviewed and quoted as an industry expert on HIPAA by Business Insurance and on self-funding by Business Week. She has consulted on a number of privacy audits, and has been successful in reducing and eliminating penalties.
